## **Kitsap Golf & Country Club Card on File Agreement**

We offer automatic payment of a member's club bill through their Visa, MasterCard or American Express credit cards. Automatic payments will be processed on the 10th of each month. Your name can be added to the list by filling out the bottom portion of this form and it in its entirety.

We also offer the option to add a credit card to your account to make payments at your discretion. The procedure we use for credit card payments is simple. When your card is on-file on your account, that information is encrypted and stored securely offsite. When you wish to make a payment, just call our office at 360-377-0166 ext. 18 or ext. 13, and we will process the amount owed from your most recent club statement utilizing your card on file. We also have the ability to send you email receipts each time your card is charged.

## DIAMOND LEVEL MEMBERSHIP

**Golf Stock Certificate:** \$1,800 **Initiation:** \$1,000 **WAIVED**

**Family Monthly Dues:** \$429.88 **Single:** \$347.61

Privileges: Use of the clubhouse, grounds, golf course, attend and vote at golf membership meetings, hold elective office, priority tee times, Legacy Membership privileges, reciprocal golf privileges at twelve different private golf courses. Up to 4 guests free of charge on designated Diamond Days Dues include unlimited golf, unlimited driving range, club care and storage for one set of clubs, locker, maintenance fund, and taxes on dues. Golf Stock Certificate is redeemable at 80% of current value upon resale as stated in the Articles of Incorporation for Kitsap Golf & Country Club. Food Minimum Charge: \$120 per quarter.

## PLATINUM LEVEL MEMBERSHIP

**Initiation:** \$1,000.00 **WAIVED**

**Family Monthly Dues:** \$429.88 **Single:** \$347.61

Privileges: All privileges of Golf Stock Membership except the right to vote, hold elective and reciprocal golf privileges. Reduced cost of meeting room rentals in the Clubhouse. Dues include unlimited golf, unlimited driving range, club care and storage for one set of clubs, locker, maintenance fund, and taxes on dues. Food Minimum Charge: \$120 per quarter.

## GOLD LEVEL MEMBERSHIP

**Initiation:** \$500 **WAIVED**

**Family Monthly Dues 19/40:** \$252.93 **Single 19/40:** \$205.24

Persons nineteen (19) through forty (40) years of age. Privileges: All privileges of Golf Stock Certificate members except the right to vote, hold office and reciprocal golf privileges. \* Family – Both adults must be under the age of 40. On your 40th birthday you are required to upgrade to Golf Stock Membership. Dues include unlimited golf, unlimited driving range, club care and storage for one set of clubs, locker, maintenance fund, and taxes on dues. Food Minimum Charge: \$120 per quarter.

## SILVER LEVEL MEMBERSHIP/TRIAL MEMBERSHIP (LIMITED TO ONE YEAR)

**Initiation:** No Initiation Fee

**Single Monthly Dues:** \$ 241.20

Dues include unlimited golf and driving range, maintenance fund and taxes on dues all other features of the club are a la carte on a cash basis. Food Minimum Charge: No Food Minimum

## BRONZE LEVEL MEMBERSHIP

**Initiation:** \$100

**Family Monthly Dues:** \$31.57 (Facilities Maintenance Fee)

Privileges: Use of the clubhouse, including lounge, coffee shop, dining and club grounds. Six (6) rounds of golf per year with payment of current greens fees. Optional Pool Usage: \$50 a month June –August. Food Minimum Charge: \$50 per month.

## JUNIOR MEMBERSHIP

Single Monthly Dues: \$55.66 Dues with driving range: \$66.56

For persons less than 19 years of age. No Food Minimum required.

*\*All members must meet the required food minimum. A food minimum is a commitment to spend a required amount on food and/or non-alcoholic beverages during your food minimum cycle. Note: if you do not spend the required amount, your member account will be billed the difference.*
